

1. During my term as "Sheridan WYO Rodeo Queen," the length of which term shall be determined by the Sheridan WYO Rodeo Queen Board, I shall not become a contestant or participant in any other beauty or talent pageant or contest to make or agree to make any public appearance of any kind without the express permission of the Sheridan WYO Rodeo Queen Board, which permission shall not be granted in any case where my participation in such event would be in violation of the rules and regulations of the Sheridan WYO Rodeo Queen Contest, Miss Rodeo Wyoming Contest or the Miss Rodeo America Pageant.
2. I warrant that all of the above statements and representations made by me are true. In addition, I agree that during my term as "Sheridan WYO Rodeo Queen" I shall conduct myself in a manner in which shall uphold and maintain the dignity and the honor of that title and position. I will not engage in any illegal use of drugs or alcohol during the extent of my reign as Sheridan-WYO-Rodeo Queen. I will not be present in a public bar while holding the title of Sheridan-WYO-Rodeo Queen unless it is the location of a (Board) required event. I will refrain from any personal relationships that could appear to encumber my ability to perform the duties of my title while attending royalty events. I further agree that during my term as "Sheridan WYO Rodeo Queen" I shall not become pregnant or married.
3. I hereby designate and appoint the Sheridan WYO Rodeo Queen Board, as my sole and exclusive representative and agent for making press releases, statements to news media, contacts, engagements and appearances during my term as "Sheridan WYO Rodeo Queen." I agree to make myself available for such appearances, interviews, filmings, tapings, photographic and recording sessions, and such other events as are determined by the Sheridan WYO Rodeo Queen Board, provided that such shall not unreasonably interfere with my educational and/or employment pursuits. In addition, I authorize the Sheridan WYO Rodeo Queen Board to collect for and on my behalf all compensation if due me by reason of the foregoing and upon collection thereof to pay the same to me; provided, however, that nothing herein contained is intended or shall be construed as any guaranty by the Sheridan WYO Rodeo Queen Board, of any contracts, engagements or appearances for the same but is intended solely to attempt to protect the honor and dignity of the title and office of "Sheridan WYO Rodeo Queen" and my personal participation and interest therein.
4. I understand that if I am awarded the title of "Sheridan WYO Rodeo Queen" that I will be obligated to enter and compete in the Miss Rodeo Wyoming competition for the title of Miss Rodeo Wyoming. I further agree that I will compete at all levels of said competition to the best of my abilities.
5. The Sheridan WYO Rodeo Queen Board may (but shall not be required to) designate my chaperon and traveling companion while I am engaged in

activities related to my participation in events as "Sheridan WYO Rodeo Queen."

6. I understand that if I do not comply with the terms and conditions of this Contract, that the Sheridan WYO Rodeo Queen Board has the absolute right to request that I resign the title and office of "Sheridan WYO Rodeo Queen" in which event I shall so immediately resign as and forfeit the right to said title and office. In addition, upon my resignation I shall forfeit and return to the Sheridan WYO Rodeo Queen Board all awards, prizes and education funds to which I would otherwise be entitled. In the event of my resignation, whether voluntary or upon the request of the Sheridan WYO Rodeo Queen Board, I recognize the right of the Sheridan WYO Rodeo Queen Board to select my successor and such person so selected shall be entitled to receive such prizes, awards and education fund as may be determined by the Sheridan WYO Rodeo Queen Board.
7. I understand that scholarships may be administered and awarded by the Sheridan WYO Rodeo Queen Board. If a scholarship is administered it will be at a rate of no more than \$500.00 per semester and must be used the year of my reign. If a scholarship is administered I have the option to receive a total of \$1000.00 from the Sheridan WYO Rodeo Queen Board to be paid directly to the college of my choice or to receive a \$1000.00 scholarship from Sheridan College. I agree to accept and abide by the terms thereof if such an award is made to me. I understand and agree that I must maintain at least a 2.0 grade point average as a condition of receiving any scholarship. I further agree to provide to the Sheridan WYO Rodeo Queen Board a certified copy of my grade transcript prior to any scholarship monies being paid to me.
8. I agree that as "Sheridan WYO Rodeo Queen" I will dress appropriately, in western apparel, complete with crown and banner, at all public appearances, and be appropriately groomed at all times.
9. I agree that this contract shall solely and exclusively determine my rights and obligations relating to my duties and responsibilities during my term as "Sheridan WYO Rodeo Queen." In the event of any occurrence or situation arising or any personal acts that I perform during my term as "Sheridan WYO Rodeo Queen" which is or are not specifically covered by this Contract which, in the opinion of the members of the Sheridan WYO Rodeo Queen Board, jeopardize or threaten the reputation of public standing of the title and office of "Sheridan WYO Rodeo Queen," the members of the Sheridan WYO Rodeo Queen Board may take whatever action they, in their sole discretion, deem appropriate, including the remedies hereinabove specified. While Board actions are Final, the Board assures royalty it will take action only based on substantiated violation(s) in regard to this contract and offer royalty opportunity for written and/or oral presentation prior to rendering a decision.

10. I understand and agree that I shall be solely responsible for my personal property and physical well-being; and that I shall neither ask for, expect, nor receive compensation, or reimbursement from the Sheridan WYO Rodeo Queen Board, its members, officers, employees or agents.

11. I agree that if chosen "Sheridan WYO Rodeo Queen" upon completion of my reign that I will return all items that are on loan to me (ex: serapes, magnetic signs, etc.) to be passed on to future title holders or pay the equivalent amount of each item to the Sheridan WYO Rodeo Queen Board.

12. I hereby release, remise, acquit, and discharge forever and agree to indemnify, defend, and hold harmless the Sheridan WYO Rodeo, the Sheridan WYO Rodeo Queen Board, it's members, officers, employees or agents for any injury or loss sustained by me or to my property as a result of participating in the Sheridan WYO Rodeo Queen Contest or any activity under this Contract. I further release and agree to indemnify and hold harmless the Sheridan WYO Rodeo Queen Board, its members, officers, agents, and employees for and from all liability to my actions and conduct during my term as "Sheridan WYO Rodeo Queen" and for its and their actions and conduct with respect to any rights herein granted.
